EXECUTIVE DIRECTOR'S MESSAGE

As in years past, during the 2021 program year, Darlington County Community Action Agency (DCCAA), rose to meet every challenge placed in its way. The worldwide Coronavirus pandemic and its impact on the health and vitality of the residents in our service area figured most prominently. The rate of infections and deaths in our small area was disproportionately higher due to the health disparities faced by many low-income residents. To the credit of the governing bodies, the management team, and agency staff members, all worked cooperatively and creatively to ensure that DCCAA's vital services were delivered to children individuals, and families in the most effective, safe, and health-conscious manner.

The 2021 program year continued to be fast-paced and productive. The issues of poverty that face our low-income families were exacerbated by the looming presence of the worldwide pandemic and the urgent push for all eligible persons to get tested and vaccinated. A focus on minimizing the spread of the virus necessitated a greater use of digital technology for many activities that were previously conducted on a face-to-face basis, including governing body meetings, and many parent/staff interactions. It also meant a return to in-person learning for our Head Start children and the implementation of our new Early Head Start

program at our Darlington, SC Center.

The issues of staff retention and recruitment were prevalent during this period. I am truly grateful for an engaged Policy Council and Governing Board that appreciated the impact of staffing issues on the success of executing our programs. Our funders also were particularly attuned to the environment and challenging issues affecting the execution of our programs.

Over the next year, we will continue to engage with the community at large to enhance our partnerships and gain even more traction in our leadership role as the chief poverty-fighting agency in Darlington County. We will continue to draw upon the commitment and dedication of our funding agencies, governing bodies, management team, staff members, and community partners to combat the causes and effects of poverty. I am proud of the success and growth of our agency and excited to see what the future holds. I offer most sincere thanks to all whose contributions make the work of DCCAA possible!

HEAD START/EARLY HEAD START

DCCAA's Head Start/Early Head Start program is the educational home to 300 the first half of the year and to 276 the second half of the year to children ages 0-to-four-year old's in Darlington County. There are two Head Start centers with 16 classrooms equipped with 32 teachers, assistant teachers, and caregivers, providing our children with emotional, intellectual, and social growth using a research-based curriculum.

Daily our children are engaged in planned and spontaneous instruction that aids their emotional, intellectual, and social growth. We ensure they receive nutritious meals and snacks, annual developmental screenings, dental and health exams, and hearing, speech, and vision exams.

Lastly, we support the family unit by providing family support/social services and linkage to community resources to strengthen relationships and engage families around children's learning and development.



HEAD START/EARLY HEAD START

Summer Food Service Program (SFSP)

SFSP is a program that helps provide public school-age children in Darlington County communities with a balanced and nutritious meal during the summer months when public school is not in session.



Child and Adult Care Food Program (CACFP)

Child and Adult Care Food Program (CACFP)is a federal program that provides meal reimbursements to childcare providers to serve nutritious meals. The program provides free breakfast, lunch, and snacks to eligible families. The program meets USDA guidelines for meals that help children grow and develop healthily.

COMMUNITY SERVICES PROGRAMS

Low Income Home Energy Assistance Program (LIHEAP)

Low-Income Home Energy Assistance Program (LIHEAP) provides funds to assist individuals with home energy bills and energy crises through Direct Assistance (DA), Emergency Crisis Intervention Program (ECIP), LIHEAP Supplemental, LIHEAP Supplemental COVID-19 benefits (LIHEAP Cares), American Rescue Plan Act (ARPA) and Low -Income Household Water Assistance Program(LIHWAP) provides funds to assist low-income households with water and wastewater bills. Project Share consists of subscriber and corporate funds from participating energy providers, which are leveraged to offer additional energy-related services to eligible clients.



Community Services Block Grant Program (CSBG)


The Community Services Block Grant (CSBG) enables **DCCAA to strengthen eligible households in** education, employment, emergency, housing, health, and youth leadership. The General Emergency Assistance Program (GEAP), GEAP Supplement, and CSBG Supplemental COVID-19 benefits (CSBG Cares) provided households with assistance for rent, water, mortgage, and medical services. Youth leadership (YLP) empowers young people to grow into successful contributing members of our communities by building character, providing academic support, and imparting essential life skills. Senior citizens were provided the opportunities to be employed part-time under the Senior Employment Program. The Job Supportive Services Program provided funds for individuals to receive tuition assistance toward a post-secondary degree/diploma, certification, or state board exam.

The Youth Leadership Program (YLP)

The Youth Leadership Program (YLP) empowers young people to grow into successful contributing members of our communities by building character, providing academic support, and imparting essential life skills.




Enrollment Statistics

Center Enrollment







2020/2021 School Readiness Comparative Report




2020/2021 Eligibility






